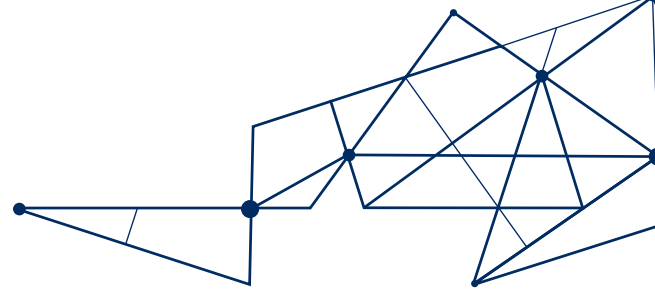




SCHEDULE OF FEES AND CHARGES 2017

APPLICATION FEE:

\$130 payable on lodgement of application for admission (non-refundable).

ENTRANCE FEE:

\$1,200 required as a condition of enrolment, payable by each family on acceptance of a place for the first son to enter the school (non-refundable).

ANNUAL FEE:

The annual fee covers tuition, education camps, notes and other teaching materials, together with subject library costs. The only additional costs to be billed during the year will be for the occasional special excursion or trip, Friday activities at Years 9 – 12, special lessons (e.g. music, tennis), cadets, bookroom purchases and uniform purchases which a student undertakes voluntarily with his parents' agreement.

FEE DISCOUNT:

An annual fee discount of 50% is offered for a third boy enrolled by a family and is effective while there are three boys enrolled at the school.
